Hearing stories of people driving 70 to 100 mph on Camelback or Northern sickens me. The NCPHA would like to start a grassroots effort to encourage all drivers to *SLOW DOWN*.

Protecting North Central for Over 45 Years

If we all drive the speed limit, it will really help others to slow down. Granted you may get a few hand gestures, but a fatality is a horrible alternative.

The City of Phoenix is getting ready to launch a city-wide Road Safety Action Plan. As a conscientious and caring community, let's get a head start on this and encourage all our friends and neighbors to slow down and drive safely. ### **Overheight Walls in North Central**

North Central is a unique neighborhood and a point of pride for our City. Being able to see front

door wreaths, holiday decorations, beautiful gardens and each home's unique architecture is a sign of a warm and welcoming community. Lately, however, there has been an uptick in requests for over-height walls. Currently, in our residentially zoned area, side and rear walls (if any) can be a maximum height of 6 feet per the City of Phoenix\*.

Adding privacy or more sound screening is typically done with trees, shrubs and other landscape materials. We want to live in an area where there is more green than concrete.

For the construction of any size wall, you are required to file a building permit with the City of Phoenix. If you live on a corner, be aware of the important and critical visibility triangle

requirements so you are not obstructing the view for vehicles and pedestrians. And remember, the wall(s) must be inside your property lines.

The Board of the North Central Phoenix Homeowners Association recently voted to oppose any variance request for walls over 6 feet in height. Walling in our community will only serve to hurt the character that we have carefully protected over the decades. What we would suggest is that you consider using landscaping material to create your borders and help reduce the heat factor in our area. For wall height violations, please contact Neighborhood Services at www.phoenix.gov/nsd.

\*If you live on Central Ave, the wall requirements are specified by the North Central Ave Special Planning District.

### City of Phoenix's Road Safety Action Plan

The City of Phoenix is launching a Road Safety Action Plan to help reduce the increasing number of accidents and fatalities. Currently, Phoenix has the worst large city fatality rate reaching a 4.4% rate increase every year, while the population of Phoenix is growing at 1.5% per year.

Last year, we had 30,376 crashes; that's 85 crashes per day with 2 serious injuries per day and one fatality every other day. This should not be acceptable to anyone living, driving, walking or biking in our city. Here are some sobering statistics: Of the fatal crashes, 46%

are pedestrians, cars 34%, motorcycles 15% and bicycles 4%.

Unfortunately, the North Central Corridor has all the attributes of the mounting crash data. 46% of all fatal crashes, 24% are younger drivers (all the schools nearby), 43% occur at intersections and 57% occur in the City's corridors.

What can you do? Every time you get

into your vehicle, please make sure you are not impaired (intoxicated, tired, angry), distracted (texting, talking, eating) and please DRIVE THE SPEED LIMIT. Slow down in school zones, any areas where there are pedestrians (The Murphy Bridle Path), and in intersections especially. Do not run red lights because you are in a hurry. We each must take responsibility for our driving/biking/walking behavior and until we do, the crash statistics will continue to rise.

Let's make a neighborhood effort to *SLOW DOWN NORTH CENTRAL* and keep our residents safe and alive. The City of Phoenix is soliciting input from residents about this growing problem. You can participate by providing feedback at: www.phoenix.gov/roadsafety or email RoadSafety@phoenix.gov

### Police Holiday Safety Tips

Four tips to protect your packages:

- Have your package delivered when someone is home or to your work
- Ask your neighbor to pick up delivered packages
- Track your package so you know when to expect delivery
- Use Security Cameras

- How to Grinch-proof your Holiday Light Display
- Turn off your light display at nightInstall Security Cameras
- Bring in valuable items at night
- Consider posting a "NO SOLICITING" sign that is visible to anyone approaching your door
- Register your home camera system with Phoenix Police virtual block watch by texting "Join Today" at 555-888

### **Barking Dogs** -

If you live near someone whose dog(s) constantly bark all day, it is very frustrating, annoying and disruptive. Since many people are still working remotely, excessive background barking is detrimental to your work environment and your quiet enjoyment of your property. Unfortunately, it's not the dog(s) fault and responsible pet owners can, if willing, find solutions to minimize excessive barking. Getting your dog to bark less will take time, work, practice, and consistency. It won't happen overnight, but with proper techniques and time, you can see progress.

The City of Phoenix has a Barking Dog Ordinance that states:

A. No person shall keep a dog within the City limits which is in the habit of barking or howling or disturbing the peace and quiet of any person within the City.

B. A person who violates this section is guilty of a Class 1 misdemeanor, however, the City Prosecutor may authorize the filing of certain cases or classes of cases as civil violations unless the person has previously been found responsible or guilty of violating this section.

## Trees and North Central ·

Did you know that North Central Avenue is a nationally designated historical streetscape? And we believe it's the only one of its kind in the entire state. Both the ash trees in the City's right of way and the olive trees on private property are historically protected. The ash trees were planted in 1972 and many remain today. Last year, due to your generosity 55 new ash trees were planted where many had been removed or diseased. Another 35 trees will be planted this season to increase the shade canopy in our beautiful neighborhood.

The olive trees are over 100 years old and for the most part, nearly all of them remain. These are the original trees planted by W.J. Murphy when the Orangewood subdivision was platted in 1895. However, if you reside on Central Avenue and are missing your olive trees, please let us know. Now that nearly all of the ash trees are being replaced, wouldn't it be wonderful to get all the olives back too? For every dollar you spend on an olive tree, you get \$2.50 back in return to the environment. They are a great tree to reduce our carbon footprint.

The City requires any new olive tree to be non-fruit bearing too. So please take care of your existing olive trees and do not cut them down. If for some reason they are failing or diseased, please replace with another non-fruit bearing olive tree. Let's Keep North Central Green.

# Health and Safety ADEQ Site Information -

The Arizona Department of Environmental Quality (ADEQ) has four active ground water cleanup projects within, or adjacent, to the NCPHA boundaries. 7 Ave and Bethany, Central and Camelback, 7th Street and Missouri, and 16th Street and Camelback. The adeq.gov websites below will provide maps showing the direction and perimeters of the underground plumes. The websites are a wealth of information and the ADEQ staff are very knowledgeable and extremely helpful.

ADEQ has provided the following information for each of the sites: Types of contamination, depths of the groundwater, if any drinking water and SRP irrigation wells are involved, future cleanup schedule projections, and some individual notes for the sites. The plume maps are available at the websites.
